THE DEFENDANT HEREBY CONSENTS TO EVERY FURTHER ADJOURNMENT OF THE CASE EXCEPT THOSE TO WHICH HE SPECIFICALLY OBJECTS, EITHER ON THE RECORD OR IN A WRITING FILED WITH THE COURT, ON OR BEFORE THE ADJOURNMENT DATE, UNTIL SUCH TIME AS HE DEMANDS IN THE LOCAL COURT A FELONY HEARING. FURTHER, IF SUBSEQUENT TO BEING HELD FOR THE ACTION OF THE GRAND JURY, BUT PRIOR TO INDICTMENT, THE DEFENDANT REQUESTS A SUPERIOR COURT CONFERENCE, THE DEFENDANT SPECIFICALLY WAIVES HIS RIGHTS TO A SPEEDY GRAND JURY PRESENTATION PURSUANT TO CPL SECTION 190.80 AND TO A SPEEDY TRIAL PURSUANT TO CPL SECTION 30.30 UNTIL SUCH TIME AS THE DEFENDANT DECLINES SUCH SUPERIOR COURT CONFERENCE OR PLEA.
